### Business Center in Bratislava

**Bratislava is a booming regional center:** the location can serve 25 million people within a few driving hours. It is not far to come to our business center.

**Tax advantages:** profits of companies in Slovakia are taxed with 22%, but withdrawals are tax-free – and this is possible for residents outside Slovakia, too.

Retained earnings in a company? A special procedure allows to transfer profits first into a Slovak Holding and then tax free to the private owner. This works within the EU and with many other countries, too.

Shareholders loans? Owners first want to avoid dividend tax and take a loan from the company. However, this increases their risk, because if the company gets into problems, the private liability is raised by the loan. With a proper structure the loan can be removed tax free.

Bureaucracy? There is no "extended duty to cooperate" if there is a tax investigation at a company of another EU country.

Because of the fair salary levels it is possible to transfer functions, to create sufficient substance for tax purposes and to cut costs at the same time.

**Malta has an EU compliant Economic and Fiscal Regime:** Special laws ensure competitive advantages within the legal framework of the EU. Costs for qualified service providers (accountants etc.) remain reasonable, and a license in Malta can be used as a passport for the EU and associated countries.

**Lowest taxes and lowest social charges in Europe:** 5% final taxation of many corporate profits (35% and 30% refund), additional incentives, social security contributions with a low maximum limit.

**Status "Resident without Domicile":** most foreigners who relocate to Malta are taxed only on income that is obtained in Malta or remitted to Malta. Capital gains that are remitted to Malta and income that is earned outside Malta and remains outside, are not subject to tax. Moving to Malta has helped many persons to get rid of legal worries.

**Special benefits for entrepreneurs:** Malta is a member of the EU, English is second official language, payments are done in Euro, the country has a mild

climate and in winter the sun rises before office hours. The economy is booming, the people are friendly and the salary level is acceptable. The population is sociable, and highly skilled expatriates like to meet in cafes and bars, exchanging ideas and listening to interesting tips and tricks.
